Certification Updates - Co-chairs provided brief overview of any recent changes to certification standards

- DNV 2021 standards beginning to survey March 1, Major updates:
  - Education standards expanded for nursing, providers and other disciplines(attached)
  - introduction of mRS assessment for all admits (premorbid, discharge for all patients + 90day for admits with Alteplase)
  - Door to needle expectation is now 50% cases in less than 45 minutes
- TJC release notes reviewed. 2021A went into effect with Jan 1 discharges and 2021B will go into effect with July 1 discharges. Both documents are attached for your review.

Survey Report Out:

- Betty McGee (St. Elizabeth) ASR (2)/PSC (3) 5 day survey virtual; Surveyor: Annette Andreoli - seemed to be utilizing checklist (vital signs/neuro checks, first NIHSS, wanted to see definitive handoffs, personalized education reflected history noted in ED, patient involvement in education - i.e. goals, etc.; therapy focused discharge NIH <2 OT was not required.</li>
  - Logistics: Monday afternoon opening presentation for all facilities; Tues: Grant/Covington Facilities back to back (ASR), Weds/Thurs/Fri was each PSC
- Rachel (ARH) ASR (4) end of Nov-beginning of Feb- all virtual
  - Whitesburg (November 2020)/Harlan & Beckley (December 2020) -focus on Alteplase records - documentation; asked lots of COVID questions - how did it effect patient care? Stroke metrics? Did not tour facility - had ER staff come to her and give interview; Were you able to meet
  - Highlands (February 2021) getting back to more normal survey; full tour; laid out expectation
  - Citations assessment/reassessment; informed consent (provider documentation); Alteplase documentation time
  - Surveyors Janine Mazabob, Delores (Dee) Behrens, Sharon Everline



• Amy Porter was able to attend Baptist Health Lexington CSC virtual survey - big focus on patient education and how it must be tailored to patient

Upcoming Surveys:

- Middlesboro (DNV) scheduled for March 2, 2021
- Chauncey @ UofL Jewish- in perpetual window; reached out to see if they are interested in virtual option; will have dry run within the week
- Amy @ Baptist Louisville virtual TSC survey in the next week or so

Hospital Requests:

- Bill Singletary does anyone have a gap analysis for 2021 standards? Lisa Bellamy mentioned that her team is working on getting that updated and will be posted on SCN website.
  - Looking into adding CTP to imaging- how many PSCs perform CTP and how has it impacted Door in/Door Out times and decision making?
    - Lynn shared how her PSCs/ASR implemented CTP and that is saved a couple of transfers to their CSC; make the case to administration about cost vs benefit (transfers avoided and patients staying at facility);
    - Chauncey shared it's important to look at where you are transferring/how long does it take? The viability of the images decreases over time; also suggested reaching out to receiving facility for support
    - Margie shared that there have been multiple times when the patient wasn't transferred to their facility because of this imaging performed at local facility
