JESSAMINE MIH TEAM

- Collaboration between agencies
- Named Jessamine MIH Team to highlight the need for collaboration
- Mobile Integrated Health refers to open communication and collaboration between all public health agencies
- Formed during the last phase of the Healing Communities Study
- Currently focused on Substance Use and Mental Health response and navigation
- Goal: "To meet the patient where they are."



How It Works

A member of the MIH Team will attempt to contact you, either by phone or in-person, within 12-72 hours following an overdose to offer support and guidance by connecting you with resources.

Your participation is completely voluntary. This team is NOT law enforcement based and cannot disclose your information without your consent.

Services Include

- Access to basic needs (food, clothing, and shelter), identification, insurance, transportation, employment
- Referrals to IOP and MAT programs, recovery centers, sober living programs, and mental health services
- Connection with recovery meetings and support groups

MIH TEAM HIGHLIGHTS

- Currently in contact with several patients for SUD,
 Mental Health, and other SDOH reasons
- Helped to Implement Buprenorphine on all frontline EMS units to treat post-Naloxone Opioid Withdrawal Symptoms
- JCEMS distributes Leave-Behind Naloxone and Resource Kits
- JCHD has installed Free Narcan Boxes in all county parks and several private businesses around Jessamine County
- Jessamine County saw a 50% reduction in overdose fatalities from 2023 – 2024 (2023 = 28, 2024 = 14)
- Falls Response and Prevention is our next focus due to high demand
